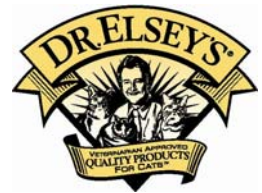

Show Hall/Hotel: Doubletree Reid Park - 445 S. Alvernon Way, Tucson, Arizona, 85711-4198; Tel: 1-520-881-4200 Fax: 1-520-323-5225; Room rate: Single \$79. TICA Hotel Policy will be enforced. Room block ends July 27, 2016.

Show Hours: Friday 3pm – 10pm ; Saturday 9am – 5pm; Sunday 9am – 4pm

Directions to Hotel: From 1-10 westbound: Take exit 264 (Irvington). At the light, turn left on Irvington Road. At the next light, turn right onto Palo Verde Road (north). Palo Verde will change street names and become Alvernon Way. Go through the intersection at 2nd Street and Alvernon Way. The Doubletree Hotel is 1/2 mile past the intersection on the right side of the road.

From 1-10 eastbound: Take exit 264B (Palo Verde Road). The road will merge in with Palo Verde (north). Palo Verde will change street names and become Alvernon. Go through the intersection at 22nd Street and Alvernon Way. The Doubletree Hotel is 1/2 mile past the intersection on the right side of the road.

Show Hotel facilities: There are restaurants located in the hotel, as well as a lounge. There is also a fitness center, tennis courts, massage therapy, pool, golf courses and more. We want to continue to have a good relationship with this hotel; please help us to maintain that relationship. Take extra care to clean up litter, food and protect the rooms from spraying adult cats.

Airport Transportation Information: The hotel offers shuttle service (6am-10pm) to and from the Tucson International Airport (TUS) for a \$25 fee for round trip.

Show Rules/Awards: All exhibitors agree by entry to abide by and uphold the show rules of TICA. Show rules and registration information may be obtained from TICA Executive Office; PO Box 2684 Harlingen, TX 78551, cost is \$7.00

Registration Rules: To register your cat with TICA, send a copy of registration certificate showing you as owner of cat with a 5 generation certified pedigree with a check for \$12 to TICA, PO Box 2684 Harlingen, TX 78551. Allow 4 to 6 weeks for processing. Per TICA rules, you may show your cat one time without a registration number; however the cat must be registered before any wins will be scored by TICA. This show will be scored for TICA International and Regional wins.

NEW BREEDS: According to TICA Show Rule 203.19, all Preliminary New Breeds (PNB) and Advanced New Breeds (ANB) must have a TICA registration number prior to any TICA show. No Preliminary New Breed, Advanced New Breed or New Traits cats may enter a show with a "registration pending"

Entry Requirements. : Entries are payable even if cat is not benched and benching will be refused unless all fees are paid. Cats co-owned by members of different households are eligible for the "second and additional" discounts only if copy of TICA registration showing the names of both co-owners is sent. Please make checks payable to **Coatimondi Cat Club** in U.S. funds. There will be a \$25 charge for returned checks, plus the original check amount. **Household Pets over 8 months of age must be neutered or spayed.**

Benching: Every effort will be made to comply with benching requests, but the Club cannot make any guarantees.

Cages: This is a BRING YOUR OWN CAGE show! Each cat will be allotted a 36" space to bench in. Oversize/grooming space is \$35.00. Walmart or Target carry pop up tents if you need one. <http://www.walmart.com/ip/SportPet-Pop-Open-Kennel-Medium-Cats-Dogs-Small-Animals/5192525>

Cat Supplies: Litter will be provided. Bring your own litter trays and food.

Exhibition/For Sale Cats: (1 Cat/2 kittens) "Exhibition/For Sale" cages are available to exhibitors only, unless special arrangements are made with the show manager. All cats must have catalog numbers to be in the Show Hall (whether named or not), submit an entry form for each one. Kittens MUST be 3 months old to enter the Show Hall. Kittens for sale MUST be litter registered and proof of age MUST be available to the Club. NO KITTENS or CATS may be confined to carriers, either displayed or under bench during show hours.

Health Rules: This a non-vetted show: All cats must be fully immunized and tested negative for FeLv. All entries must be free of fungus, fleas and ear mites. It is advised that all cats be bathed and groomed prior to benching. ALL CLAWS MUST BE CLIPPED PRIOR TO BENCHING.
